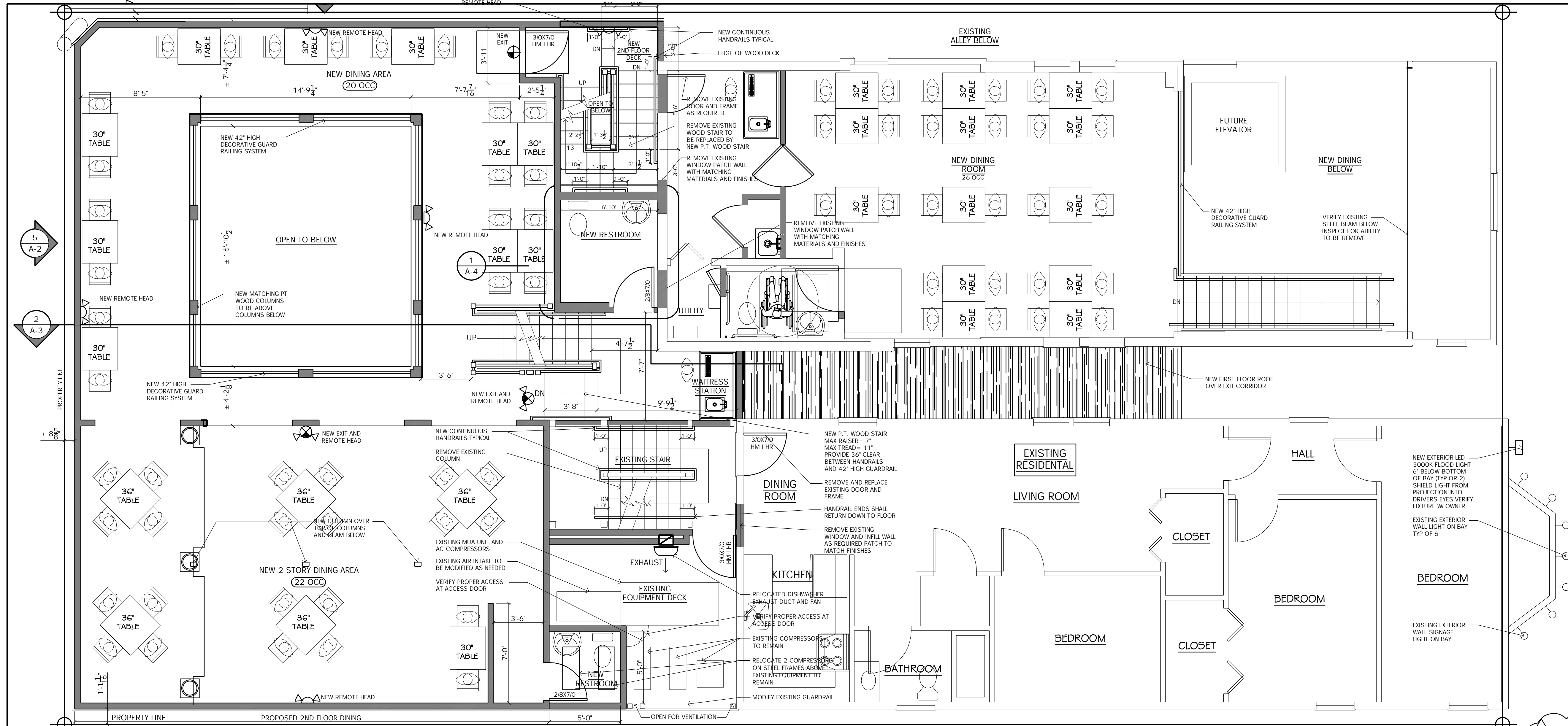

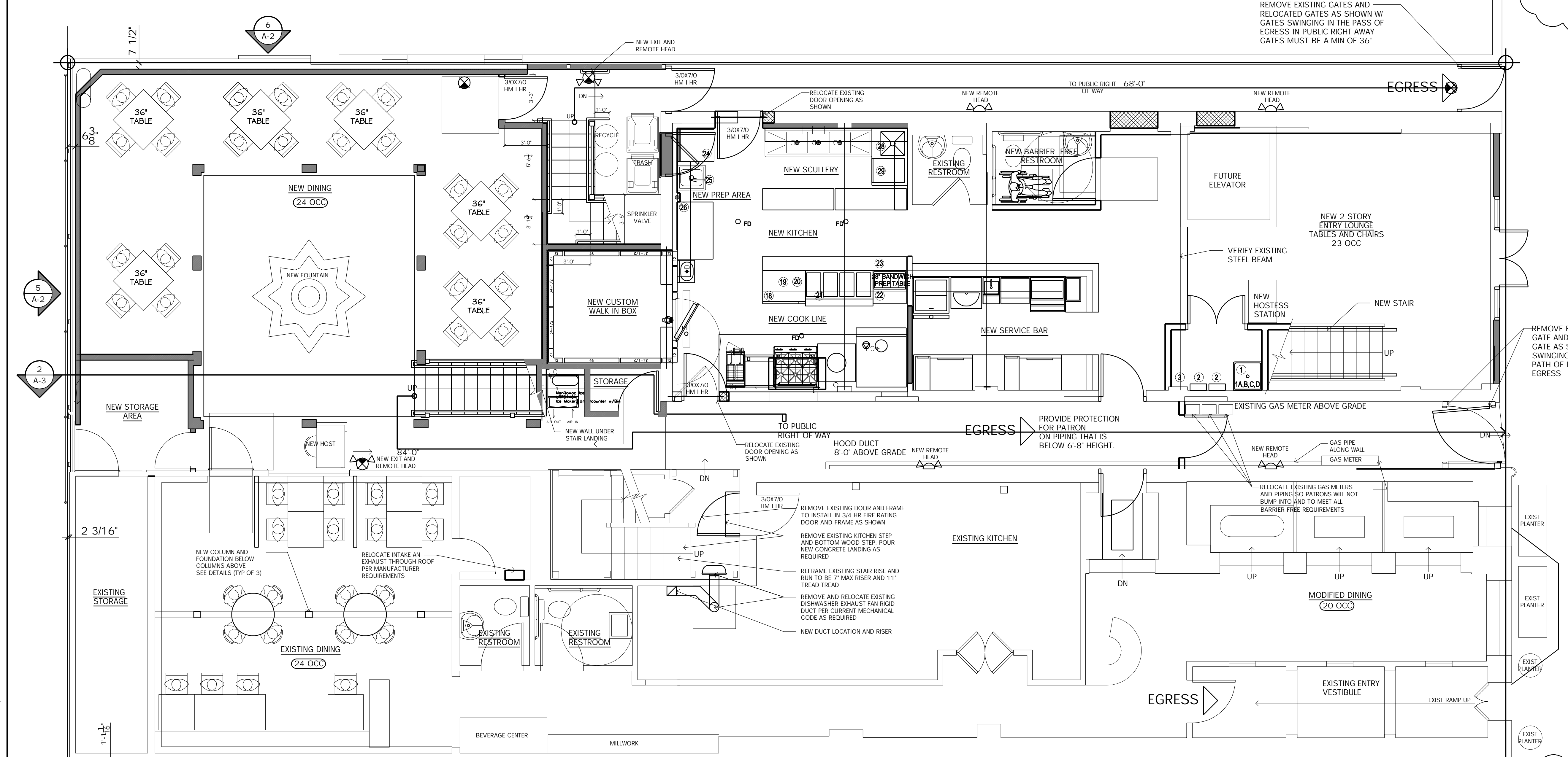

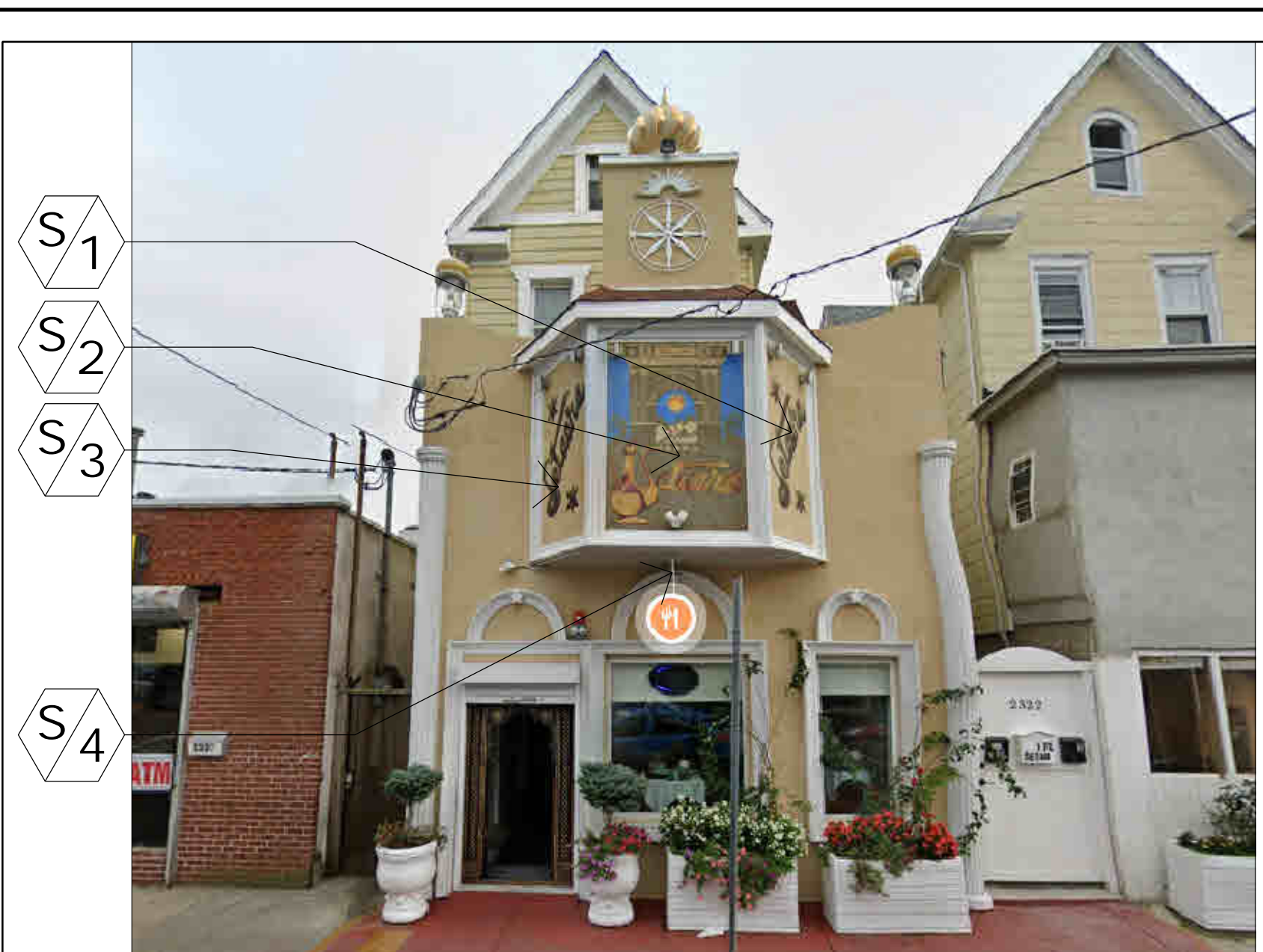
SECOND FLOOR PLAN

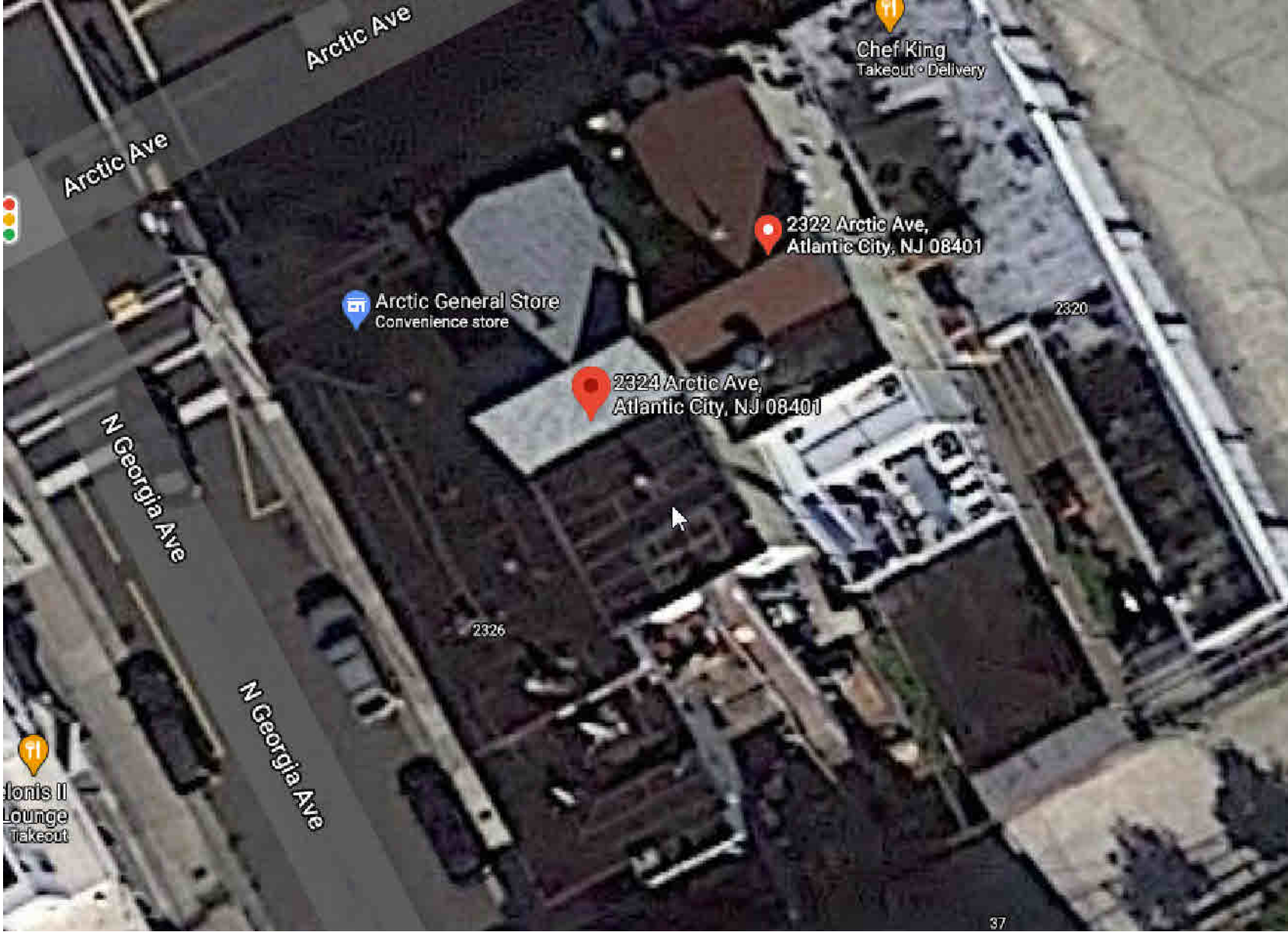

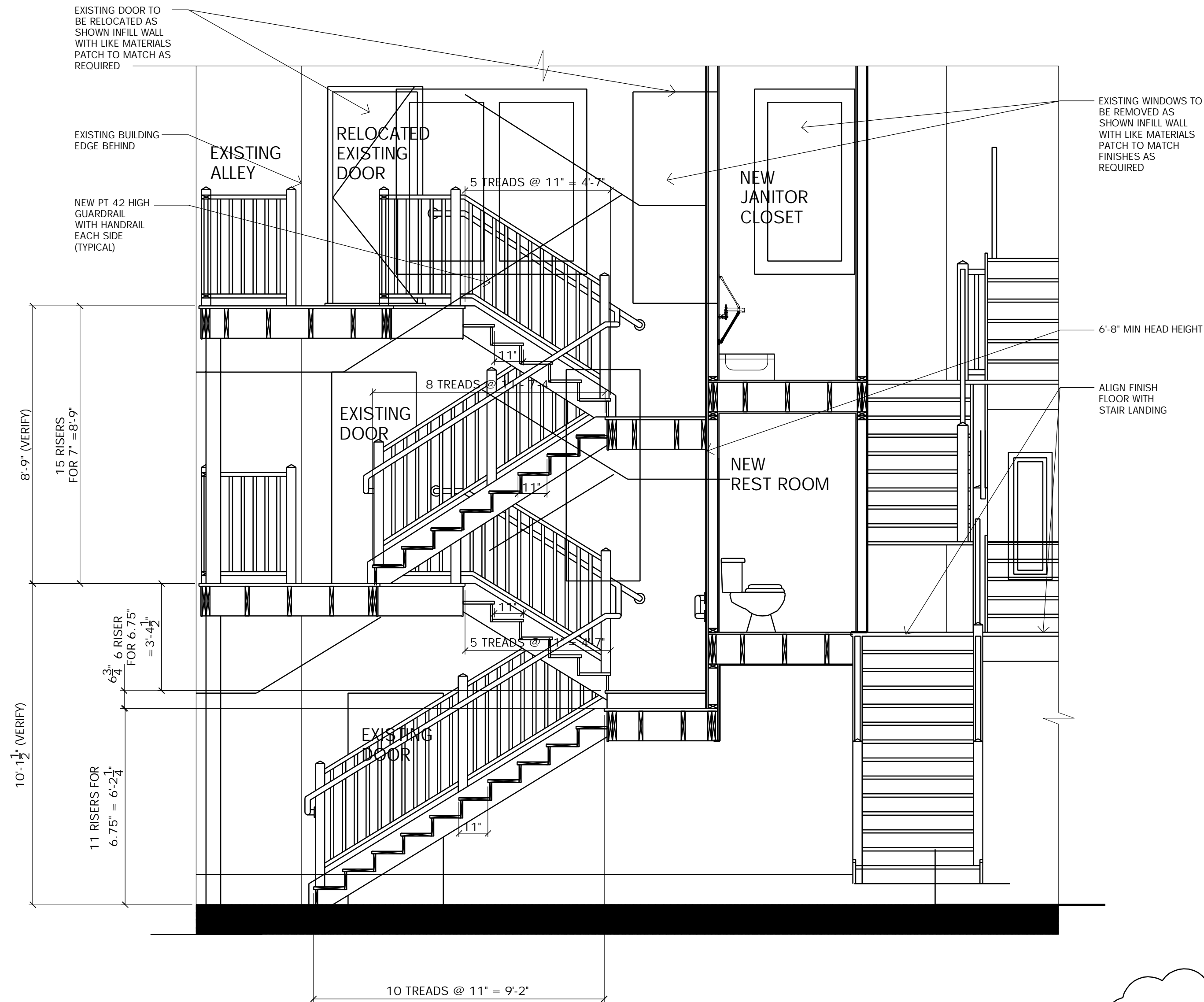

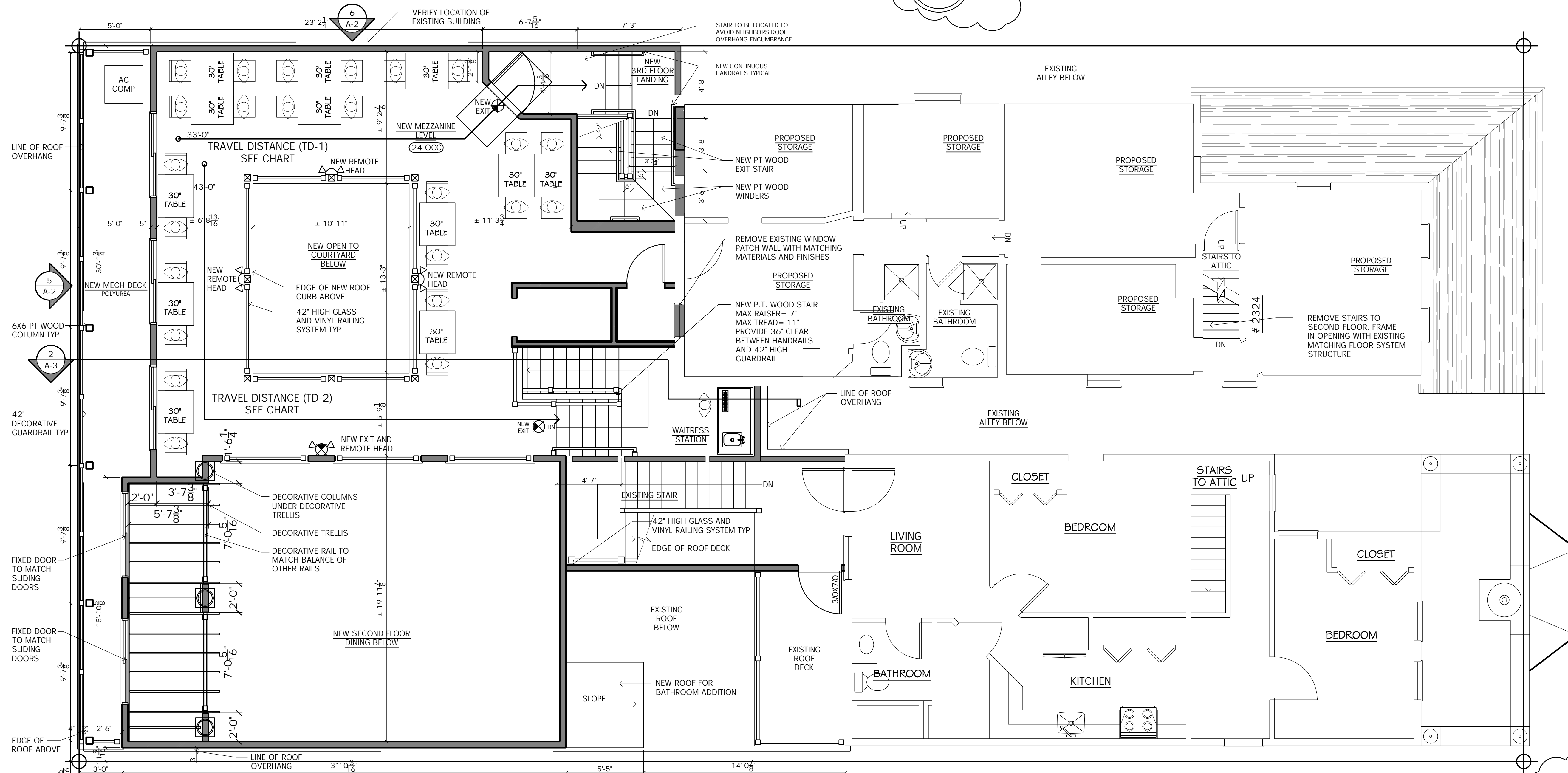
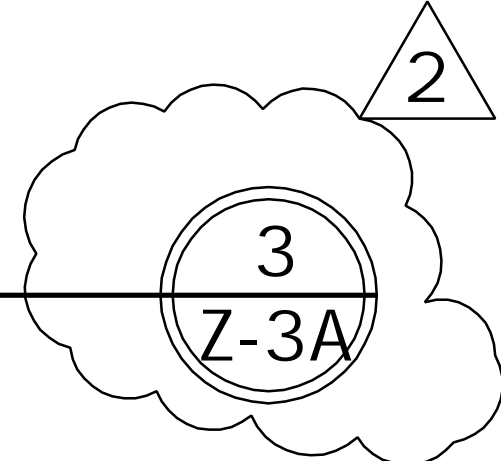
PARTIAL ROOF PLAN

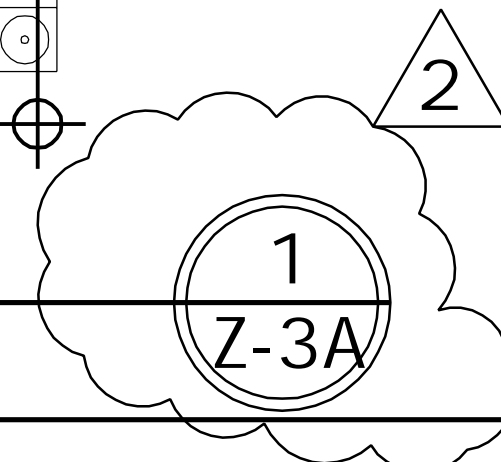
COURTYARD SECTION / ELEVATION

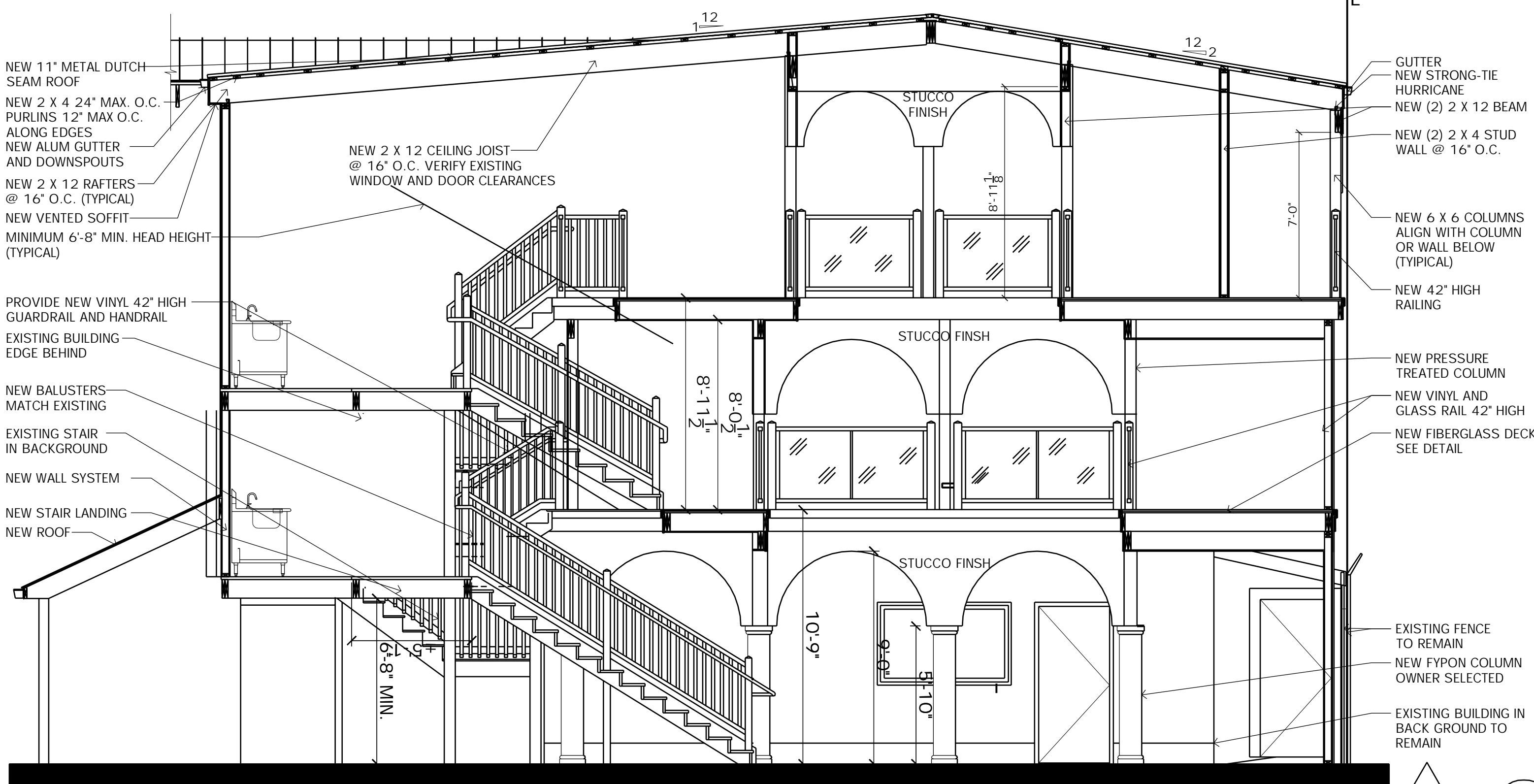

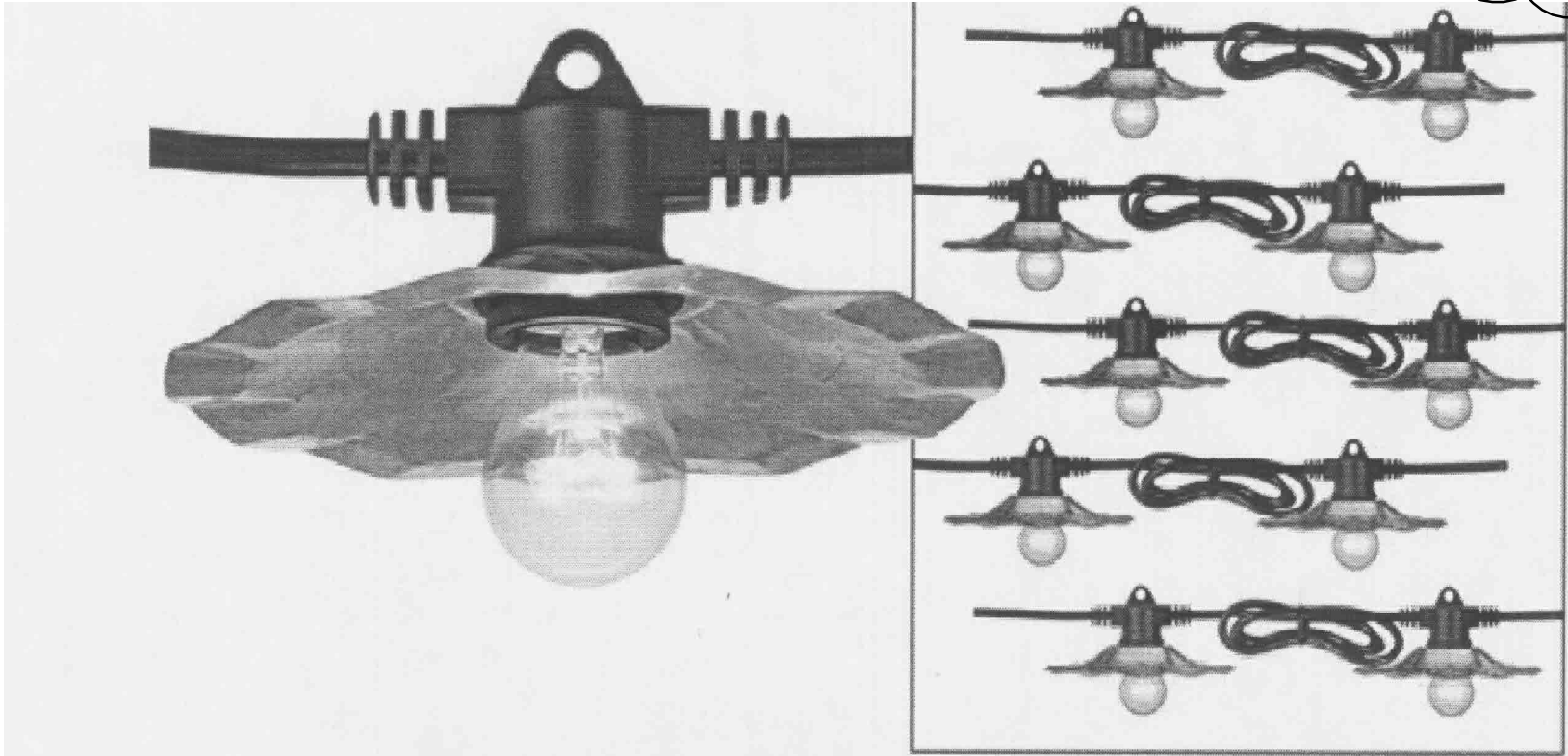
EXTERIOR ELEVATION
