Council Members SHABAZZ, MARSHALL & RANDOLPH Present the following Ordinance:

AN ORDINANCE AMENDING CHAPTER 243 SECTIONS 24 AND 78 OF THE CODE OF THE CITY OF ATLANTIC CITY, WHICH REGULATES LOADING ZONES

WHEREAS, City Code, Chapter 243-24 states the locations described in Schedule XX (243-78), attached to and made part of this chapter, are hereby designated as loading zones, and no person shall stop or stand a vehicle at any of said locations except for loading and unloading materials; and

WHEREAS, the Director of Planning & Development has proposed and amendment to Section 243-24 (Loading Zones) and the corresponding Section 243-78 (Schedule XX: Loading Zones) to include a loading zone on Maryland Avenue, West Side, from a point 83 feet north of Atlantic Avenue to a point 104 feet north (see attached Plan); and

WHEREAS, this matter was considered by City Council's Planning and Development Committee on May 30, 2024; and

NOW, THEREFORE, BE IT ORDAINED by the Council of the City of Atlantic City that Section 243-24 (Loading Zones) and the corresponding Section 243-78 (Schedule XX: Loading Zones) of the Atlantic City Code be and is hereby supplemented and amended as follows:

SECTION 1.

To Include a Loading Zone:

SECTION 2. Any Ordinance or parts of any Ordinance inconsistent with the provisions of this Ordinance are hereby repealed to the extent of such inconsistency.

SECTION 3. This Ordinance shall take effect immediately upon its approval by the city engineer, final passage and publication as provided by law.
