Council Members MARSHALL, RANDOLPH & SHABAZZ Present the following Ordinance:

AN ORDINANCE AMENDING CHAPTER 243 SECTIONS 24 AND 78 OF THE CODE OF THE CITY OF ATLANTIC CITY, WHICH REGULATES LOADING ZONES

WHEREAS, City Code, Chapter 243-24 states the locations described in Schedule XX (243-78), attached to and made part of this chapter, are hereby designated as loading zones, and no person shall stop or stand a vehicle at any of said locations except for loading and unloading materials; and

WHEREAS, the Director of Planning & Development has proposed an amendment to Section 243-24 (Loading Zones) and the corresponding Section 243-78 (Schedule XX: Loading Zones) to include a loading zone on South Kentucky Avenue, East Side, from a point 74 feet south of Atlantic Avenue to a point ~~55~~⁹⁵ feet south (see attached Plan); and

WHEREAS, the City Engineer has reviewed the Plan and approved the proposed loading zone on South Kentucky Avenue; and

WHEREAS, this matter was considered by the City Council Planning & Development Subcommittee on September 4, 2024; and

NOW, THEREFORE, BE IT ORDAINED by the Council of the City of Atlantic City that Section City Code be and is hereby supplemented and amended as follows:

SECTION 1. To Include a Loading Zone:

Name of Street	Side	Location
South Kentucky Avenue	East	From a point 74 feet south and to a point 95 feet south from the intersection of Atlantic Avenue and Kentucky Avenue

SECTION 2. Any Ordinance or parts of any Ordinance inconsistent with the provisions of this Ordinance are hereby repealed to the extent of such inconsistency.

SECTION 3. This Ordinance shall take effect immediately upon its approval by the city engineer, final passage and publication as provided by law
