The following is an explanation of the changes to the submitted drawings for approval for the above mentioned project:

Outstanding Comments:

- The site triangle at Bellevue Avenue has been modified with a 18'-0 distance from the edge of the travel lane as show in the NJDOT Roadway Design manual figure 6-A. Drawing 5/Z-3 shows the modified site triangle as requested. The tree plant C has been remove to improve visibility.
- 2. The owner will get a letter to clarify the location of the parking lot to be used during banquet hall events and give a copy to Casino Reinvestment Development Authority as required.
- 3. The tree labeled plant "C" in the south planter has been removed and replace with plant "A" mixed perennials to remove the previous obstruction to the site triangle. There are still three plants labeled C in the north plant and Florida Ave planter. We have selected white dogwood trees with a 15 to 30 foot mature height (Cornus Florida) for the two trees in the north planter and one in the planter along Florida Ave.
- 4. Attorney / owner will apply to Atlantic City for a revocable license agreement as required.
- 5. Attached is the onsite and offsite improvement cost estimate as requested.
